Anti-Ragging Committee

In order to prevent incidents of ragging inside and outside the campus, an anti-ragging cell has been constituted as per the guidelines of PCI, New Delhi and AKTU Lucknow. The purpose of the said committee is to control ragging or any type of harassment to newly admitted students. The committee will hold meetings at regular interval with the committee members and inform the findings to higher authorities of the Institution. Following activities will be regarded as Ragging -

- Abetment to ragging
- Criminal conspiracy to rag
- Unlawful assembly and rioting while ragging
- Public nuisance created during ragging
- Violation of decency and morals through ragging
- Injury to body, causing hurt or grievous hurt
- Use of criminal force
- Assault as well as sexual offences or unnatural offences
- To force to do menial jobs for the seniors.
- To ask/answer vulgar questions.
- To force look at pornographic pictures to shock the fresher's out of their innocence.
- To force to drink alcohol, scalding tea, smoking, etc.
- Extortion
- Criminal trespass
- Offences against property
- Criminal intimidation

Responsibilities of Anti-Ragging cell

- Members will carry out regular checks for any Ragging activity in their areas as per schedule.
- Surprise checks should be carried out in probable areas of ragging.
- If any incidence noticed on the spot, necessary action to be taken and informed the cell immediately.
- Ensure anti ragging instructions are displayed at prominent places in their areas of control.

DISCIPLINARY MEASURES FOR RAGGING

Depending upon the nature of the offence as established by the Anti-Ragging Cell of the College, the possible punishments will apply for those found guilty of ragging:

All

- Cancellation of admission.
- Suspension from attending classes.
- Debarring from class test/examination or any other evaluation process.
- Collective punishment when the individuals committing or abetting ragging are not identified.
- Rigorous imprisonment and fine as per Law.
