- · Abetment to ragging
- · Criminal conspiracy to rag
- Unlawful assembly and rioting while ragging
- · Public nuisance created during ragging
- Violation of decency and morals through ragging
- · Injury to body, causing hurt or grievous hurt
- · Use of criminal force
- · Assault as well as sexual offences or unnatural offences
- To force to do menial jobs for the seniors.
- · To ask/answer vulgar questions.
- To force look at pornographic pictures to shock the fresher's out of their innocence.
- · To force to drink alcohol, scalding tea, smoking, etc.
- Extortion
- Criminal trespass
- Offences against property
- Criminal intimidation

Responsibilities of Anti-Ragging cell

- · Members will carry out regular checks for any Ragging activity in their areas as per schedule.
- Surprise checks should be carried out in probable areas of ragging.
- If any incidence noticed on the spot,necessary action to be taken and informedthecell immediately.
- Ensure anti ragging instructions are displayed at prominent places in their areas of control.

DISCIPLINARY MEASURES FOR RAGGING

Depending upon the nature of the offence as established by the Anti-Ragging Cell of the College, the possible punishments will apply for those found guilty of ragging:

All

- Cancellation of admission.
- · Suspension from attending classes.
- Debarring from class test/examination or any other evaluation process.
- · Collective punishment when the individuals committing or abetting ragging are not identified.
- Rigorous imprisonment and fine as per Law.
